HYC CONTINUED ITS PROMOTORA PROGRAM AS A COMPONENT OF IN-HOME FAMILY PRESERVATION SERVICES, WITH PLANS TO EXPAND THIS PROGRAM TO AUGMENT ADDITIONAL HYC FAMILY SERVICES PROGRAMS. PROMOTORAS PROVIDE CULTURALLY BASED MENTAL HEALTH SUPPORT TO CAREGIVERS TO REDUCE MENTAL HEALTH STIGMA, IMPROVE FAMILY COPING SKILLS, AND LINK FAMILIES WITH ACCESSIBLE SERVICES.
